All ties to be played week commencing Monday 20th. February 2012 (as per handbook)

Please ensure your players are eligible to play by reference to the rulebook.

Three teams have been disqualified this season due to infringements of the Rules, please check the Cup Rules!

Home teams to give opponents a minimum of Seven days notice of date of match. It is both courteous and expedient to check that your opposing secretary is aware of your arrangements.

Please note only ONE doubles to be played per match in divisions 4 & 5

Games played 11up. Best of 5

Can I please ask Home Club Secretaries, in the event of a walkover (match not being played), it is a requirement that the **HOME TEAM** send in a match card to Match Secretary Trevor Owen asap, stating which Club has conceded the walkover.

And an appeal to all home club captains to post the match card as soon as possible after the match, it speeds things up, and saves a fine!!

The next round are the SEMI - Finals. - Please start thinking about the Cup Regulations!

Your attention is drawn to Cup Regulation 5, 5a & 5b on page 21-22 of the current Rule Book and page 13 of current handbook

5. A player whose registration is received by the Fixture Secretary after 31st. December, shall not be eligible to play in a cup match except by permission of the Management Committee.

5 (a) A player is not eligible to play in a Cup Semi Final or Final unless he / she has played for their Club a number of League matches equivalent to 45% of **League** matches played by the team appearing in that Semi Final or Final rounded down to the nearest whole number

5 (b) A player may not play in a semi final or final if his / her eligibility to do so has been obtained by playing for one or more higher team/s during the preceding four calendar weeks.

7. ALL players taking part **in a CUP match** must be present and available to play **at 7-30 pm**. Any player not available at the stipulated time when called upon to play shall forfeit such set unless a reserve is available, who once introduced, shall play for the remainder of the CUP match.
