## **Editorial**

I must open with an apology for the extremely late publication of this month's issue. All kinds of reasons are advanced for late publication of the magazine and this season, as usual, we have had the usual amounts of hints about it at my expense. I don't really mind this, in fact I thrive on it, but I do feel it's time one of the major reasons was highlighted.

Besides the divisional writers there are a number of people who have to submit articles at varying stages of the season and these are published every season, and yet I still have to remind those concerned that material is due. This is always greeted with surprose, followed by vague promises and the required material then arrives, usually at least 10 days later than it should have done. At the time of writing there are eight contributors who have not yet sent in their notes or articles. The score cards were sent out two weeks ago but only four out of eight sets of notes have arrived. Each season I arrange of material. The magazine has been in existence for many years and everyone is well aware that we have one issue per month after the New Year. From this it should be obvious that if the magazine is to be published on time then all material should be to hand by the 14th of each month at the latest. It is with some regret that I have been compelled to make this decision for I have enjoyed the job immensely. I have tried to make the magazine as interesting and topical as possible but it can be an unrewarding task. In January we produced an issue which several people have said was our best for some time. I anticipated replies to some of the letters published, but there has been little response, in spite of the fact that it is obvious I am prepared to leave out other material to make room for your letters. The fact that the magazine can only remain topical if you answer the letters and articles which appear has still not got home to most of you.

We now need someone to take over the job from me and it is open to any member of the League who would like to take it on.

## FAULT!

Those who watched the English Open on television must surely have been a little disappointed with the controversy which surrounded Jovner's service. Briefly what happened—and was apparently seen on television (I was there at Crystal Palace so I didn't see the T.V. coverage but saw it "live")—was that Istvan Joyner, the loose-limbed athlete from Hungary, was playing Stefan Kollarovits of Czechoslovakia in the Final of the Men's Singles. Unfortunately Joyner occasionally served in such a way that the umpire was unable to see the actual service. In other words his stance was such that his body was blocking the umpire's vision of the service. us, however, get this point clear. The umpire acted absolutely correctly however much this reflected on Joyner. The first such service was halted with a call of 'Let' and the umpire explained why he had called 'Let.' It is just possible Joyner did not understand the reason but the fact the umpire spoke to him must have convinced him it was not 'Let' for the more usual reason—the ball had touched the net in service.

When a second service, some time after was produced where again the official in charge could not see the ball he acted, I felt, with courage in faulting the offender. He could have pretended he had seen the ball and said nothing. Maybe everyone would have been happy. National Umpires, however, are expected to carry out the laws of the game to the letter and this is what happened.

Not unnaturally Joyner—who is a first-rate sportsman—was most unhappy. An appeal had to go out for the interpreter to come to the officials table to explain the position.

I would rather have expected the interpreter—an important member of the party—to be on hand anyway. Of course at this time thousands were watching their T.V. but instead of thrilling table tennis they saw a dispute on the rules.

Fortunately the whole thing was satisfactorily resolved and the game continued. Kollarovits eventually won, but in my opinion he probably would have done so anyway. It certainly couldn't be called a shock result.

One or two things arise. How could the incident have been avoided? As I've already said, the umpire could have ignored the fact he couldn't see the ball. umpire did was observe No. 9 in the Appendix to the laws of the game. Couldn't he move his chair? I would After all, how is the think not. umpire going to be sure he can see from another spot? A service judge? Perhaps a possibility but there appears to be nothing anywhere which allows one to be appointed. Had Joyner been pulled up before? I hadn't seen him so I can't answer Certainly if any umpire couldn't see the ball he should have been.

It should not, though, be difficult to produce a service which is visible to the umpire—99% of the players do it easily enough. Providing umpires are consistent in applying this law there can surely be no repercussions.

Our umpires are regarded as some of the best in the world. Requests for them to officiate at World and European championships prove that.

Just one incident—in an earlier round it would have gone unnoticed but what a pity it took up valuable T.V. time!

It was decided by the Committee that we should try to establish our Open Tournament as a "Graded" tournament by the ETTA and to do this it was necessary to conform to the special conditions laid down by the ETTA. The one item that affected us cash-wise was the giving of prizes in cash and you can see from the summary that these cost us £105, most of this being in cash. It was obvious that this first effort would result in a loss and in fact, although some items are estimated, the loss of £29 is much smaller than was originally estimated. Considerable efforts were made to find our own sponsors for this event and in fact over 50 letters were sent to local business houses but all we received were good wishes from the few who replied.

If we do receive recognition by way of being graded then we can expect some financial support in future, but if we do not then obviously, in my opinion, we cannot afford to run this event each year on the same scale as this.

# The Merseyside Open

The prospects of "Graded Status" for the Merseyside next season and the importance of everything going off well kept those concerned extremely busy during the weeks before the 'Open' and the fact that everything did not go as smoothly as we would have liked was, I suppose, only to be expected.

Due to the necessity to increase the entry fees to help cover the vastly increased prize costs there was a sharp drop in local entries and it became unnecessary to have any Friday evening play. We had to try and retrieve this money by some means, especially as we had no sponsorship, and the raising of entry fees was an automatic necessity. This may not have met with everyone's approval but a study of the finance report of the tournament will show that it was certainly justified.

To comply with one of the "Graded Status" conditions a time schedule of events had been prepared and was prominently displayed. A great deal of work went into preparing this time-table and, despite a 15 minute late start, the times more or less worked out as estimated, until the later stages when the Mixed Doubles once again caused delay. In spite of this time-table being on display, and kept to, the number of players making enquiries re times of various events did not show any decrease from previous years. The Finals started 45 mins. late at 8-15 p.m. This compared favourably with some of the 'Open' tournaments I have watched this season. They were concluded at 11 p.m. without any upsetting results.

The entry for the Men's Singles was not as strong as in previous years and it was also necessary to scratch two seeded players due to non-attendance. This gave the Men's Singles event in particular a rather lopsided appearance, both scratched seedings coming from the same half of the draw. It also meant that Denis Neale won the title without ever being extended. This did, however, result in the well-deserved and very popular appear-

ance in the Men's Final of Derek Scholfield. He defeated P. Abell 17 and 15 in the semi-final, but lost to Neale 15 and 14 in the Final. The other losing semi-finalist was Mike Johns who lost to Neale 7 and 17.

The Finals were very poorly attended, but I think the absence of the two seeds had something to do with this. Those present did see, however, some very fine doubles matches which helped to compensate for the Men's Singles event. The Mixed Doubles final was by far the best of the evening and the audience were not slow to show their appreciation of this closely contested set. The partnership of Mike Johns and Maureen Robson finally getting home 21-19 in the third against Neale and Sue Howard.

Another see-saw struggle took place in the Men's Doubles when Neale and Ransome beat Johns and Landry 21-17 in the third. The Women's Doubles was also a 3-gamer in which the Howard sisters defeated Bashford and Robson again at 21-17 in the third.

I must express my sincere thanks to all those who assisted in the running of the tournament, both local players, our own officials and the non-Liverpool League officials for their voluntary assistance. Lack of space prevents me naming them in person. I, the Referee, am very grateful for their many contributions. Unfortunately the helpers were the same few who always assist but if we achieve the hoped for "Graded Status" then we will need far more assistance next season from local players than we get at present. There was far too much dependence on the non-Liverpool League officials and the regular local helpers for voluntary assistance when this assistance should have been forthcoming from our own officials and the local players.

The League's thanks must also go to Dunlops Sports Co. for once again allowing us the use of this fine venue in which to stage our Tournament and for which we are extremely grateful.

With the season nearing completion the promotion and relegation issues are still far from settled. Trinity, Colonsay 'A' and Knotty Ash are still battling for second place and it is still anybody's guess which of these teams will accompany Linnets into Division 1. At the time of writing Colonsay have 134 points from 22 matches, Knotty Ash 124 from 20 and Trinity 120 from 19. At the bottom, relegation seems now certain for English Elec. 'B', W'loo Park 'A' and L'pool YM 'B' with the other place still to be decided, probably between Trinity 'A' and Sparta.

L'pool YM 'B' seem to be setting up a mutual aid society with a couple of clubs. When they played W'loo Park earlier in the season W'loo turned up with only 4 players. A little later in the season the Y.M.

played with 4 players at Eng. Elec. and in the return, guess what—Ing. Elec. turn up with four players. I know many clubs support the idea of 4-a-Side but starting your own 4-a-Side league is not quite the thing.

The duel between the two Colonsay teams resulted in a draw with no less than 8 sets going to three. I wonder what time the match finished? My sympathies must go to Alan Guy in this match for he lost both his sets 23-21 in the third. Good performances were put up by D. Goodwin of the 'B' team in beating Les French two straight and Brian Leeson, also of the 'B' team, in beating Harry Nelson 14 in the third.

Linnets have added the Rumiahn Cup to their already won league title. They won by 3 sets after two drawn games with Knotty Ash. The first match was undoubtedly the most exciting with every call going the way of the team that picked it. This meant that Linnets, as the away team, led right through to 5-4 and had to win the last set to take home Their captain, Frank the cup. Thomas, was the man to play and fortunately for Knotty Ash he was defeated in the third game. replay was fixed for a week later. Before writing about this match I must have a moan. The Jewish club was again picked as the venue, but did anybody tell them? Most of the players and the official in charge were waiting outside the club for 30 minutes before one of the players went to the secretary's house to get a key to let us in. About an hour later Mrs. D. Cohen, who provided excellent refreshments. arrived-she only found out the match was on at 7-45 p.m. on the day. I wonder who is at fault here? This time Knotty Ash won the toss and again calls went as picked until at 3-all John Baron beat myself to make it 4-3 to Linnets. Phil Blake then beat Derek Dorman and Linnets were 5-3 up. Knotty Ash then put Derek straight on again and this produced a very good win for him over Tony Green and made it 5-4. This left Barry Clarke to play Keith Jackson, Earlier in the season Keith had beaten Barry but there was no

stopping Clarke this time and he produced some fine table tennis to win two straight and make it another draw. The sets were counted and Linnets took the cup by 3 sets. In closing I would like to mention the fine play of Ian Burrows, Knotty Ash, in his first season back after a bad road accident, and for Linnet's Phil Blake — their best player, winning all his sets in the two matches.


