EDITORIAL

Postponements for all the wrong reasons have again marred the past season and we reached week 22 with the usual high number of outstanding matches still to be played. Biggest culprits have again been 1st division teams, some of whom seeming to believe they must only play if both sides are at full strength. Acceptable reasons for a postponement are given in M.R. 9. Postponements because a team cannot be at full strength are not allowed, promotion or relegation issues often being affected if they take place. Next season the M.C. must take a firm line on this issue and any Home team agreeing a postponement outside the Rule must have the match awarded against them. This same action should also apply if an official postponed fixture is not replayed within the agreed time limit of six weeks.

Such a hardline may be considered as unfair, but it will only be those seeking to gain an unfair advantage by protecting their promotional aims or seeking to avoid relegation who are likely to see it in that light. The proper way to look at is that some weeks after the season ended it was still not possible for our F.S. to produce a final league table, matches affecting P & R still requiring to be played. Teams were playing matches in the final weeks going back to October. This has to be unacceptable and must be stamped out. If you cannot field your best team for any reason then you must use a reserve or play short. The only way of ensuring fairness all round is for the M.C. to stop pussyfooting round and fully enforce our Rules.

The ETTA have done a 'U' turn on the bigger ball issue and it now seems likely they will be asking its AGM to endorse the full adoption of the bigger ball. This has to be a sensible decision in that we cannot have a situation whereby those who play at tournament, B.L., County level etc play with the new ball one day and the next in their respective league with the exisiting ball. Whether its adoption will bring about the hoped for improvements remains to be seen.

Another area were a change may take place will be that of service. If the trials being conducted next season are successful the necessary rule changes will be made and they will operate from season 01/02. This will be a much needed change and ensure the receiver and the umpire can see the ball at all times. All that will be needed is full enforcement at all levels. At local league level in particular the current service rule is ignored by most players, some not appearing to know the difference between vertical and horizontal and many totally unable to judge a height of six inches. Any attempt to call a 'fault' generally being greeted with abuse and a row breaking out. Where application of Rule is concerned we are weak and ineffective at most levels, local level being the most ineffective of all. Time for a change, perhaps?

L&C LEAGUE

END OF SEASON REPORT

For the 7th season in a row I am able to report that at least one trophy has ended up in the Leagues's possession. Over the past four years the Men's and Ladies team have walked off with their respective divisional crown, in addition we have annexed a Veteran title and three cups. I am delighted to report that our League's success story continues with another Men's Div.1. championship, two Veteran championships and two knockout trophies having been won. I will deal later with the disappointing aspect of the ladies competition.

The Men's squad of Keith Williams, Paul Hutchings, John Rankin and Ken Jackson won every match and finished five points ahead of 2nd placed Mid Cheshire. This being the 5th year in succession that the major divisional title has been won by our League and achieved without call on all of the leading players. Adam Robertson played just once due mainly to his heavy diary of events at home and abroad which has seen him play in two world championships within the space of seven months, a European championship, plus 16 matches for his team in Germany. Keith's seven 1st division winners' medal is, I believe, a record for the L&C League. John collecting his second with Paul and Ken picking up their first. There have been more exciting campaigns, but they did enough to see off the opposition. The only blip being the Bolton match, when Ken stepped in for Keith and won one in a 6-4 victory, and the home match against Mid Cheshire when Adam and John beat Brian Johns in a 7-3 win.

The Veteran's 'A' team started out in 1994 and won the Div.6, title, took the Div.3, title in '98 and this season have won the div.1, title. Alan Chase and Ted Birch have been regulars throughout the seven seasons and thoroughly deserve their success. Dave Evans was also a regular with Ricky Brown and Alex Johns stepping in when required. I have said in previous reports that no team has been more reliable and this again applied under Alan's guidance. They have also been perfect ambassadors for the league. The present regulations prevent the team from pitting themselves against the Premier division big boys as a league is not allowed to have two teams in the top divisions. It is possible that this regulation may be changed by the L&C league AGM. Well done, the team.

Yet another championship title came to the new Vets 'B' team in Div.4. South. The team, ably led by Alex Johns, won all seven matches, dropping just 8 sets in the process, three being walk-overs when they played short. Supporting Alex, who was unbeaten, were Brenda Buoey, Ahmed thabet, Sue Burgess and Mike Power.

Stockport finished as Premier champions for the 12th year in succession and remained unbeaten, ending the season just two points ahead of our team of Keith, Ken Jackson and Peter Lee. It could have been so different if a 5-4 lead had been converted into a 6-4 win when Keith faced Roger Hampsopn in the decider. It was not to be, the wily old campaigner beating the Liverpool champion to force a draw. We had earlier lost to Blackburn, but victory against the champions would almost certainly have brought home the title.

As the first league to simultaneously hold the Dennis Smith Memorial Trophy and the Norman Cook Memorial Trophy in 1999, it was a tall order to expect both to remain in the League's hands for another year. For the 2nd time in 3 years Keith, Ken and Peter took on the LBH at Cadwa in the 2000 Final. In what was a tremendous advert for veterans table tennis, the match swayed one way then the other. Liverpool took a 2-0 lead via wins by Ken and Keith over Ian McElwee and Mike Mahoney respectively. Their rivals hitting back to level the score, Bob Edwards beating Peter and Mike overcoming Ken. At 4-2 up we looked home and dry only to see Mike and Bob ensure the tie would go to the wire by notching wins over Peter and Ken and level the score at 4-all. Keith, though, was in devasting form. sweeping Ian aside to retain the cup by ensuring us a 5-4 victory.

One week later Keith, John Rankin, Ken Jackson and Brenda made the short trip to St. Helens to face Mid Cheshire in the Norman Cook final. The Cheshire side took the opening two sets but we pulled back to 2-2 with wins by Brenda and Ken. At this point they called their banker, the Men's doubles, and when Brian Johns and Terry Turner led by a game and 20-16 the set looked in the bag. But Ken, playing in place of Paul Hutchings who was unwell, returned the next two serves as winners as he and Keith pulled back to 20-all before winning 30-28 and then winning the decider. That seemed to deflate the opposition and after John and Brenda had cruised to a straight games mixed doubles victory the stage was set for the clash of

the clash of the top two players. Brian Johns won when they met in the league, but on this occasion, even with a 3 point start in each game, the England No.2. was unable to cope with a brilliant demonstration of clever play by Keith. He won in two straight to clinch the match and the cup for a record 7th time for both himself and the league.

The Ladies won their opening match 10-0 but were unable to raise a team for an afternoon match at Oldham. Paula was working and Delyth was at a long standing function in Wales. The home side, having earlier postponed a match when they could not raise a team, were in no mood to offer us a new date within the agreed time scale, hoping, in my opinion, to claim the points. Brenda then contracted a mystery virus in December and again we could not find three players for the next match. At this point, having been advised that Paula was ineligible due to her not having played the requisite number of Liverpool League matches, the decision was taken to withdraw the team. They have been champions ten times since 1987 and it was disturbing to have to resort to this action. Although Delyth will not play in Liverpool next season, hopefully we will be able to re-instate our team next term.

This comes down to your own club secretary whom you should all appreciate greatly because it can be a thankless job. I think you should all stand up and give them a round of applause.

I know that more than one secretary has had a 'bit of bother' this season that has impinged on their social life and peace of mind. It is up to all of us to make their jobs as easy as possible and one of the ways you can do so is to know the Rules of our League. If you make a mistake and break those rules, no matter how innocent it may appear to you, the Management committee has to act. This can result in a loss of points to your team, fines and suspension of players. No one in our Leauge, including the Management Committee, wants to see this happen. I would ask you all to try and make everyone's job easier by knowing and obeying those rules. If you are ever in doubt about a rule you can always telephone a member of the committee who, I am sure, will be more than pleased to assist you. A serious incident did occur during the season and the resultant punishment has led to our Appeal Board being called on to adjudicate following an appeal by the club and players involved. Details of the Appeal Board findings can be found elsewhere in this issue.

It would be remiss of me not to add my condolences to the family and friends of the recently departed Bath St. player, John Watson, who sadly passed away earlier this year.

It would also be remiss of me not to wish our President, Arthur Upton, all the best. Hope we see you back at committee meetings before too long, Arthur, after your on going illness.

A reminder to all Club secretaries, return your Club membership form for next season in good time.

An Appeal Board was convened at the request of the Management Committee and sat on 10th May 2000 to hear an appeal by L'pool YMCA and two players, Alvin Tso and Paul O'Donnell.

The Appeal Board members were Eddie Cameron, Appeal Board Chairman, Tom Edge and Brian Leeson. Also present were Peter Lee, Liv YM Secretary, representing Club and players. The two appellants, Alvin Tso and Paul O'Donnell. The Mangement Committee were represented by Ken Armson.

The Appeal Board had been provided with all relevant correspondence and copy of the Management Committee Disciplinary Hearing of 22nd March.

From the outset the Club's representative accepted as true the allegation that Paul O'Donnell had played for a lower team than that for which he was ranked and had been entered on the scorecard under the assumed name of Robert Aldridge. The two players also confirmed the allegations were true.

The case against the L'pool YM and the two players having been verified and proven left the Appeal Board to comment on the validity of the league's punishment for the offences. As the decisions of the Managment Committee were as per Rule the Appeal Board were only able to make recommendations.

Having heard the representations from both sides and taking all aspects of this appeal into consideration and accepting the apparent naivity of Paul O'Donnell the Appeal Board recommendations were:

- 1. The suspension period for Alvin Tso be reduced to eight league match weeks.
- 2. The suspension period for Paul O'Donnell be reduced to five league match weeks.

Other aspects and punishments to remain unchanged.

Subsequent similar offences cannot be tolerated and could well attract harsher sentences.

Another season finally comes to an end and it's no surprise to me that we all have to congratulate Merseyside Police 'A' for their total dominance throughout the season. Paul Gittins strolled through the season with the top average, only 2 defeats, the latest being at the hands of Alan Jones from Maghull 16, -16. 16, this coming in a top of the table clash which ended 7-3 to Police. The quartet of Paul, Steve, Terri-Ann and Gemma 'Lager' Lloyd can look forward to next season in the top flight which I am sure they will all enjoy. Paul and Steve have played there before so it will not come as a shock to them, but for the girls it

In their final game Marconi 'A' met Waterloo in Huyton and the visitors ran out victorious in a closely fought game 6-4. This time it was Ricky Brown's turn to complete a hat-trick of wins, Frank lost out to him 21/18,

-18, -19. Frank also fell to the unorthodox Ritchie Cragg 19, -19, -21. Although Frank lost, it sounds as though he got his monies worth. Peter was the home sides main success story beating both Peter Holmes and Ritchie and losing narrowly to Ricky.

Bootle J.C. finished the season in fourth place and proved all the way through that they are a hard team to beat. Apart from the teams above them, nobody gave B.J.C. anything like a thrashing. Manweb beat them 7-3 but B.J.C. played a reserve in the shape of Dave Graham (what shape is that). Dave, however, having suffered a loss of match practise due to injury, didn't disgrace himself taking both John Hardy and Alan Evans to three games. Brian Crolley had a good season with victories over Mark Miles, Peter Wass, Alan Jones and Trevor Owens. Mike Moran had good wins against lan Wensley, Mark Miles, Roy Adams and two wins in a 7-3 defeat against Maghull beating Alan Jones and Fred Pheysey -18, 18 & 19. Roger Neal was as steady as ever and his claim to fame came earlier in the season against Maghull (please see previous Digest).

Both Manweb teams were not only playing for second division survival but were battling against each other and were evenly matched throughout the season. Both teams eventually finished on 96 points apiece. Had it not been for a mid season injury to Andy Lloyd, the 'A' team may have put one over their first team. The first team managed to take three points off Police 'A' over the two games. The first match ending up 9-1 but according to Paul the score didn't reflect the match. John Hardy had tough luck against both Paul and Steve losing 21/17 to Paul and 24/22 to Steve, both in the third. Alan Evans won the sole game for Manweb beating Gemma 11/21 in the third. The return match finished 8-2 with Terri-Ann being the unfortunate one losing to both John and Paul Evans but recorded a good victory over Alan 18/21 in the third. Maghull then beat them by the same score and their final game was at the hands of Bath Street, losing 7-3.

WSM'B' ended with a flourish, winning four of their last six matches including an incredible win over promoted Maghull. Would you believe the score ended up 9-1 with Steve Woods saving a whitewash, but only just, beating the much-improved Tim Ternent 19 in the third. I have to say in defence of Maghull that Fred Pheysey didn't play, but nevertheless this was an impressive win. Both Mark Miles and Roy Adams won their three and teamed up to win the doubles but the win of the night was reserved for young Tim who beat Alan Jones 14 & 10, well done. They followed this with a 7-3 win over M'web, Mark again winning his three. Tim narrowly losing to John Hardy 19 in the third. They then beat Marconi 'A' 6-4 before losing 8-2 to Bath Street, but played a man short. They then drew with Bootle J.C. and rounded of the season with a resounding 7-3 win over Police 'B'. Next season, evervone beware!

It's obvious to me that there is someone out there, and that you do in fact read these notes. I have received more cards this time around with comments on them than I have received since I started putting pen to paper. Thankyou to all those who have contributed. Hearty congratulations to the double winning Cops, Police 'C', Gareth Jones, Len Dyson, Dave Crispin and Brian Burrows, ably assisted by Dave Oakes, who have romped home (some time ago) to claim the 4th div. title. 22 wins, no defeats, a massive 194 pts from 220, 88%,

surely some kind of record! They took the Forrest Cup by beating their nearest rivals, WSM 'E', 5-2 in the final.

Police have felt slightly embarassed to be here, questioning the Committee's decision to place such a strong team in this division, as justified by a finish of five consecutive 10-nils. From the beginning the question has not been if they will win, but rather by how much. Across the 22 matches it's been their commitment and single mindedness of purpose that has made it look easier than it actually was, avoiding any pitfalls of complacency. Gareth can testify to the abilities of the No 1's and 2's in the divisions that ensured he doesn't leave us unscathed. Len and Dave have both beaten the 4th div. Individual champion, Harry Reeve. Jubilant runners-up, WSM 'E', Bob Owen, John Gratton, Gordon Langshaw and Ken Roberts, also ascend into the upper echelons. Bouncing back from whence they came, with promise of a permanent settlement in the 3rd. Their last match of the season had them on 139 pts playing rivals H.H. 'A' on 126 points who still had a postponed match to play. WSM 'E' knew they needed at least 4 pts to be sure, as if H.H. 'A' won 7-3 they could steal it 143 to 142 if they beat Cadwa 10-0 the following night. Sadly for H.H. 'A' they were without the unbeatable Mr Clein for both matches. WSM 'E' clinched the runner-up spot with a 5-all draw. Bob Owen bt John Henshaw (from a game down) and Paul Morgan. John Henshaw bt John Gratton, who in turn thwarted Mike Poole. Bob has made a habit of comebacks, btg Phil Christie -18, 18 & 23, and Harry Reeve 19 in the 3rd. They've made good use of reserves Ken Armson and Andy Bird, alongside of standout performances from the regulars, such as John Gratton taking Bert Rivers 17 in the 3rd; Gordon Langshaw btg Jack Highton 24 in the 3rd and Ken Roberts overcoming John O'Sullivan after losing the first.

So, Harold House take 3rd place in what was a very good season with an improved squad. Eddie Clein has had another standout and landslide season,

The closest anyone got to Eddie was Ken Armson, 17 in the 3rd. Their 2 v 3 clash with WSM 'E' came just too late and the draw was a good result considering they were without Eddie's services. They came closest to upsetting the Police with a 4-6 result, Eddie btg Gareth and Len and John Henshaw also btg Gareth narrowly 19 in the 3rd. A 10-0 v WSM 'G' saw Paul Morgan recover from 15-20 down in't 3rd against Paul Reed-Clayton to take the next 7 points. Mike Poole also came back from a game down and 9-16 in the 2nd to beat Ken Ray. They've covered Eddie's obligations by having Ritchie Blackburn and the venerable Dave Cohen playing a round.

M'web 'B', who settled down to a mainstay of Cameron, Ashley and Harrison, again finish behind H.H. but two places up on last season, and with visible signs of improvement in the camp. An 8-2 defeat by the Police 'C' in February was quite a close affair, 4 sets going to a decider, but only Gareth v Paul Evans -20. 20 & 20 going to M'Web. Alan Cameron taking the other point beating Gareth in 2. A 10-0 defeat from the Police in the return fixture could be forgiven, however, wins over Boo YM 'A' and W'loo and a draw with M'hull have to be weighed up agst defeats from WSM 'F', WSM 'G' and H.H. 'A'. A solid performance over the season, which recommends them as a team to watch for next season.

M'hull 'C' have come on leaps and bounds from last season's efforts and will be well pleased with 5th spot, seeing it as an opportunity to go that extra yard next season. Their draw away to M'web was mainly due to Phil Christie having the luck/skill to win both his singles in the 3rd, 24 & 19. Steve McGanity also won his two that night btg John and Arthur and has followed this with good wins agst Don Davies, Arthur Garnett and Ken Roberts. Impressive 7-3 wins over Cadwa 'D' and Boo YM 'A' were balanced agst defeats from WSM'S 'E' & 'G' to define their position in the pecking order.

Bath St 'E' always looked like they were too good to go down and although the wheels came off, they're still singing. Losing to both promotion chasers, WSM 'E' and H.H. 'A' but Alan Willis btg Gratton and Roberts, and Chris winning the battle of Blackburn from Richard. Everyone in tune winning one single and then both doubles to beat M'hull 'C'. Karen Gibson has been solid at No.1. regularly beating the opposition 1 & 2s. Due to illnesses Chris has appeared as the No 4, 3 & 2 but was capable of winning both sets at any position.

A reconstituted Boo YM 'A' have had some hard battles, both personally and as a team. Bert Rivers has been toying with his bat, losing more than he would like. Jim Geddes boasts a comeback victory over Frank Lacey. Mike Hughes in 3 over Austin Hayden. Bert and Jim teamed up to enjoy a 19 in the 3rd win over Langshaw and Roberts. They've come together as a team for recent wins over Bath St 'E' 6-4 and W'loo 'C' 7-3, with Arthur Garnett resplendent as usual. They also had the unusual experience of starting a match in one venue and finishing it in another, when Cadwa 'D' were moved out of the main hall to the small hall. this may have explained why they lost all 5 of the sets that went to 3. At the end of the season W'loo will be glad to have done a 'Bradford' and finished just above the relegation zone, managing to stop a free fall of successive season drops. In what was the equivalent of one of those head to head cycle races,

were the two riders do 5 circuits of the velodrome at a snails pace and then one of them bursts for the line, W'loo on 58 points with a game in hand, met WSM 'G' on 60 points in match 18. and so it came to pass that W'loo accelerated past WSM 'G' 9-1 to establish a six point lead, which they held onto, as they gained 21 points from their remaining 5 games, as did WSM 'G' from their last 4. On that defining night, Harry Nelson, Ken Nelson and Austin Hayden took top honours and both doubles, with Ian Douglas responding for the opposition v Bill Spencer, they see-sawed through the remaining games, down 2-8 at M web, up 9-1 to Cadwa (3 pts w/overs), level at Bath St 'E', down for nought at Police and finishing off even stevens, again with Bath St. T. WSM 'G' proved their mettle last season by beating stablemates WSM 'E' in a tiebreaker to claim the 5th div c'ship. Next season they will be competing for the same trophy. A 10-0 defeat from a strong H.H. 'A' (5 games lost in the 3rd) didn't help themselves or their challenging 'E' team. A good 10-0 against the Police in so much as 4 sets went to three. Andy Bird involved in two of them, the closest being -23, 18, -18 versus Len. A 6-4 win over M'hull 'C' gave hope. Sadly, their penultimate match, a 10-0 over Linacre, their best result of the season, did no more than extend the gap between the two teams. their final game, a 7-3 win over Boo YM 'A', notable for Paul Reed-Clayton as he out foxed Rivers and Geddes, was not quite enough. Even though the team has gone down, expect to see guest appearances for the surviving WSM team from Andy, Paul, Ian and Steve. Linacre will be looking to whitewash the wall whereupon the writing has been written. Last year's eleventh hour up turn could not be repeated, and the 5th will be welcoming one of the finest hosts in the league. A second win of the season came against Bath St 'E', in no small part due to 4 games being w/overs. Their finest hour came in an impressive draw against WSM 'E' in March. Harry losing to Bob, but too good for John. Jack Davidson beating Gordon, and best of all, Bob 18 in the 3rd. Neil Appleby losing his two but having chances at deuce in each. Their last game was a home defeat 4-6 by Boo YM 'A', Jack Davidson losing to Bert 19, -18, 19, but triumphant over

| Arthur in 3.

As I surmised at the start of the season, WSM with three teams in the one division had several options open to them, when it came to how they "packed the bases". As prophesised, giving one team the leg up to the next division, can push another down. WSM finish with one team promoted, one mid table, one relegated. As ever with table tennis, joys and tears dispersed in equal measure.

Peter Carney must be feeling well pleased with the rewards for his return after a lengthy absence. for A'burth it was a much harder season and at times they doubted their ability to gain promotion back to the 4th, but they need not have worried for their nearest rivals, Bath St. 'F' were well adrift. They had their share of problems and the sudden disappearance of Dave Evans at a crucial point in the season did not help. Waiting in the wings, however, was Carl Anderson who surprised himself and his club with a series of good results when he stepped in on several occasions to assist his 1st team. Carl is a by product, so to speak, of the league coaching sessions, in that he is not a junior. He was snapped up by Aigburth who have been more than pleased with his reliability and results. He won his two agst M'web btg Ron Houghton and Ray Finnigan. Playing for the

Ist against the 'A' he again won his two beating Derek Traynor and Eric (Twinkle toes) Young. Twinkle toes because he surprised me, probably a few others, with the excellence of his dancing footwork at the Presentation Night, his wife's also. Carl is a player to watch out for next season, who knows, his club may give him a crack at the 4th div.

Bath St 'F' and M'hull 'D' tried hard to stay with A'burth but surprisingly it was not to be for Bath St, who had the strength in depth to compete but could not convert that strength into match points. Obviously they will now see themselves as probable front numers next season.

Most teams won the matches they expected to win and there were few surprises. Liv YM did produce one when Tony Wong beat Delyth Davies in 2 straight to make it an unhappy season for Delyth. Not that she will be too bothered, her education being more important at present than winning matches, but this should not detract from what was possibly Tony's best win of the season. The big question now being will we see Hope back with us next season? Rumour has it that we may not. What has been a serious problem in a division already short of teams and matches is that of walkovers. Far too many have occurred and these have resulted in less matches for the teams affected. Hope were one of the offenders and yet still succeeded in finishing above Police 'D' even after a ten point deduction for playing an ineligible player. As last season, Police remain firmly anchored on the bottom and yet have players in their squad who could have improved their position had they played more often for their own team.

The season was marred by a serious breach of Rule by L'pool YM 'C' that culminated in their being expelled, the Management Committee decision having been upheld by the Board of Appeal. they failed to learn from an earlier offence, showed a total disregard for the league rules, and left little room for any other decision. Fortunately the subsequent adjustment of points made necessary by their expulsion has had no effect on most placings. Perhaps the YM's behaviour is more adequately covered by comments on the scorecard for their match against M'hull 'D' which read "Only one YM player, Alvin Tso, turned up at 8.30pm. This being the second time this season they have failed to turn up for our match. I don't know what's going on at L'pool YM, it's

frustrating for every one."

Clearly there are lessons to be learnt by every team from this incident. The most important being that Clubs should ensure their players are fully familiar with Rules governing ranking and eligibility of players. Hopefully it will all be history next season and everyone can pick up where they left off this season and get back to playing table tennis and at the same time ensuring they operate within the league rules.

The main aim now has to be ensuring that there are twelve teams competing in this division and so ensure a full 22 week match programme for everyone.

WHAT CONSTITUTES AN INELIGBLE PLAYER

The word 'ineligible' in Rule 19 has led to some confusion as to its exact interpretation so far as playing order is concerned. Your Management Committee have looked into this and agreed Guidelines on its exact interpretation so far as an offence is concerned. The main definition so far as Clubs are concerned being that the word 'ineligible' will only apply to a player who plays for a team that he or she is not eligible to play for. To simply play out of order does not deem that player is ineligible.

CLOSED CHAMPIONSHIPS REPORT

For the first time we made use of the additional tables available to us using 15 for match play and a further four for practice play. This enabled us to maintain the schedule of play and still have tables available for practice. Several members have asked why we play across the venue and so have some tables directly in front of a white wall, it being felt that the use of orange balls is not sufficient to compensate for a facing white wall at one end of a court. There are two reasons for this, the first being that this enables maximum court layout without using all available space. The second, and by far the most important, being that we have insufficient surrounds for any alternative layout. At the GP in August we were able to move away from the wall and have a passageway round the perimeter of the 24 tables because the sponsor provided the additional surrounds required. We hope to shortly be in a position to purchase additional surrounds and if these become available we will use a layout with all round access. LH courts will still be facing a white wall but this will not as now be the court perimeter and we will continue to use orange balls. As they will then be the new larger size balls they will be even easier to see. I decided to do a complete 'U' turn for the O55s by making it a Group event followed by a k/out. This gave early competitors more matches and appeared to be well received. It did add to the overall running time and as always with veteran events a number of games were prolonged. I had allowed for this, but what you cannot allow for is who will go though to the later stages. It was this factor that caused some delay to the Divisional singles that followed the O55s, but we succeeded in introducing the O40 event on time. Again, the delay factor was related to competitors playing in all three events and several progressing to the later stages. The recovery time I had included in the scheduling assisted in compensating for some of this delay and helped us keep up to schedule. The WS with only seven competitors ran well, but the JS with only three competitors probably created more problems than any other event. This being due to one of the competitors in that event arriving late for the D5 event resulting in the JS not being played as scheduled during the O40 event. With another also competing in the WS I was un-

able to get the JS started until the WS groups had been played. By that time we had commenced the MS and had a further knock on effect due to two of the JS players also being in the MS. We still made good progress and commenced introducing Doubles matches shortly after 5p.m. as planned. This is always the most difficult time due to players still being involved in the later MS stages, some MS matches running slightly behind schedule not helping. It only takes a couple of long matches in either event to bring about problems and we had a number in both events. Had everything run smoothly with players being knocked out to order and so becoming available for their next event, we would have finished at the planned time of 1830 to 1900. Sods Law being what it is play did not finish until 19.40. Everything had been cleared and everyone was away home by 19.55hrs. The usual small band of helpers being the last to leave. I was pleased to see more members assisting in the dismantling of courts and removal of equipment than is normally the case. This is a time consuming task made easier if we have the assistance of members, it being for your benefit that we run a tournament. We set up the previous evening with a much smaller band comprised of Committee members and two others. It was necessary during play to have a slightly prolonged General Let to enable presentations to be made to O55 and DS finalists. I know some players found this to be a bind, but it was a necessary bind. Prior to moving to the Tennis Centre, there was a prolonged break in play whilst officials took lunch followed by DS finals and presentation of trophies. I have eliminated the lunch break (we eat as we work) and events including finals are played on a continuous basis. This benefits everyone with the exception of officials - they run the risk of indigestion etc. It follows that there needs to be a break if we are to ensure that finalists are to be properly presented with their award. We also had new perpetual shields to present to D2 & 3 winners, purchase of these having been made possible by an anonymous donation. It was important to ensure that these new trophies were properly presented. If anyone felt aggrieved by this break in play they should reflect on the fact that it could just as easily been themselves on the receiving end of one of these presentations. There is never a right time for such a break and to have allowed play to finish on all tables before making the presentations would have incurred a disruption in play of up to one hour. Not

to mention being besieged by players demanding to know why their match was not being played when tables were obviously available. .Finals Night went well, too well, for we had to adjust the programme of events because one of the WS finalists was delayed, only to find play proceed at such speed that all possible matches had been completed by 2100hrs and we were still without both WS finalists. The spectre of being the first league referee to scratch a finalist zoomed into view, the only way of avoiding doing so being to have a short break. This becoming a 30 minute break, Paula arriving at the time she had said she would of 21.30. We still succeeded in finishing well before 22,00hrs. Because Finals Night tended to run late the programme was reduced to ensure a more acceptable finishing time. However, we may need to review this decision and add at least one additional match or alternatively move the commencing time forward and give us a finishing time of around 22.00hrs.

In conclusion my thanks to all competitors for their support, assistance and co-operation and for the many donations received. My special thanks to the small band of helpers who worked throughout the day to help make the tournament the success that I believe it was. I shall be studying the schedule of play with a view to moving the doubles event to an

earlier slot. It may still create problems, requiring

as it does four players for a match, but anything

that makes the day easier for officials and competi-

tors is worth considering. Any change may also

eliminate the inevitable scratching that is part of

any doubles event.
